<b>Potential Health Effects (Acute and Chronic):</b>	Chronic: May cause liver and kidney damage. Sophisticated modeling has clearly proven that 2-butoxyethanol does not build up in the body under any kinds of normal use.

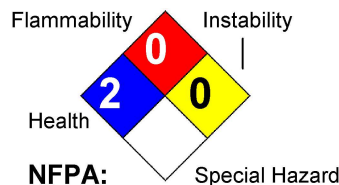
